WHEREAS the Founder Trustee is desirous of constituting an Educational Trust of a public nature for Educational and charitable purpose.

AND WHEREAS the Founder Trustee is desirous of Irrevocably endowing and setting apart a sum of Rs.1,000/- (Rupees one thousand only) in cash and all the assets valued Rs.3,000/- (Rupees three thousands only) as mentioned in the schedule belonging to the school presently carried on under the name and style of "VIDYAMANDIR MATRICULATION SCHOOL", of which the founder trustee is the absolute owner, at T.H.Road, Kokkumedu Village, Ponneri Taluk, Trivellore District.

NOW THIS DEED OF DECLARATION OF THE TRUST WITNESSETH AS FOLLOWS:

1. The Trust constituted shall henceforth be known as "VIDYAMANDIR EDUCATIONAL TRUST".

2. The Founder Trustee declares that the movable properties mentioned in the schedule hereto shall be hereinafter held by "VIDYAMANDIR EDUCATIONAL TRUST"

3. The objects of the Trust in general are:-

(a) to run, establish, found, organise, start, promote, construct, maintain, develop and improve Educational Institutions for the benefit of students without distinction of caste, creed or religion.

(b) to start and run educational institutions, technical schools, work shops, training centers, scientific research institutions or any institutions to propagate and achieve higher technical and scientific knowledge among the friends and people in respect of the objects mentioned above and also to adopt and manage any existing educational schools and institutions.

(c) to acquire, take over or merge any institutions with the similar object to further the cause of spreading technical, scien-

(g) to institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitrations or attend any legal or other proceedings, claims or disputes by or against the trust or trustees or against it's officers, or employees concerning the affairs of the trust and to sign and verify vakalaths, pleadings, affidavits and or other papers.

(h) to deligate all or any of the powers, authorities and directions vested in the trustees to any individual or committees and generally to carry out such transactions as they consider

expedient in the interest of the Trust and to make all such arrangements and to such acts and things on behalf of the Trust as may be usually, necessary, desirable or expedient in the management of the affairs of the Trust or in carrying out it's objects.

(i) to provide for scholarships, means, books, accomodation, clothing and monetary help to deserving, needy, helpless and destitute children irrespective of caste, creed and religion.

(j) to give donations for other educational institutions with the object similar to those herein contained.

4. The Trust shall be managed by a Board which shall consist of two trustees viz., Smt. Hemamalini, wife of G. Purushothaman, Founder Trustee and Sri. G. Purushothaman, son of G. N. Subbaramaiah, The Managing Trustee.

(a) The Managing Trustee and the Founder Trustee may also co-opt if found necessary, representative/s from the parents, representative/s from the teachers and also any outsider/s who is/are having an interest in the field of education.

(b) The Founder Trustee and the Managing Trustee shall hold their office for life.

(c) The Managing Trustee or the Founder Trustee can retire voluntarily and they shall in such an event nominate Trustees for the Management in their place.

(d) In the event of death of the Founder Trustee or the Managing Trustee or both, their legal heirs shall ipso facto become Trustees.

5. The Funds of Trust herein before conveyed will form a corpus to which shall accrue all future accretions, profits, incomes, donations and properties that may be earned or received in due course.

6. The Trustees shall at no time be entitled to appropriate to themselves any revenues of the Trust except that may be reimbursed any actual expenditure incurred by them on behalf of Trust. They are also entitled to receive a remuneration for services rendered to the Trust.

7. The Trustees shall have power:

(a) to receive and to accept contributions, donations and gifts in money or property of any kind either by way of addition to the Trust Funds generally or for any one or more of the specified objects of the Trust and such contributions shall be dealt

either as capital or as income according to the directions of the donors at the time of the gift or contributions and the Trustees shall do all things as may be necessary to act upto the wishes of such Donors.

(b) to buy, sell, construct, develop, take on lease, tenancy, exchange, grant or transfer immovable properties where it is deemed expedient or necessary for carrying out the objects of the Trust.

(c) They shall have full powers to manage the Trust, it's properties and funds. They shall likewise be entitled to take all steps that may be reasonable or required for the preservation of the Trust and the Trust's properties.

(d) To apply for and obtain grants or loans from the Government, Local authorities, or other authorities, Banks, Companies, Firms, Individuals and Institutions on such terms and conditions as they may think fit in regard to security and interest and shall for this purpose be entitled to mortgage or charge the properties, of the Trust as may be necessary.

(e) To frame necessary rules and regulations for proper and convenient administration of the Trust, and to act according to such approved rules and regulations.

(f) To keep and manage the accumulated funds for the aims and objects of the institution.

8. Investments and documents of title shall be made and taken in the name of the Trust itself.

9. The Bank Account or Accounts of the Trust shall be opened in its own name and operated by both the Trustees jointly and/or severally for and on behalf of the Trust.

10. The Trustees may meet together as and when they think fit to consider important matters concerned with the Trust and its management.

11. Minute Books shall be regularly maintained for the resolutions passed at the meeting of the Trustees present.

12. The Trustees shall arrange for the maintenance of correct and proper account of all receipts and payments and for proper audit of the accounts of the Trust, every year.

13. The accounting year for the trust shall be one year commencing

14. The Trustees shall cause to be prepared and shall lay before a meeting of the Trustees all annual accounts and statement of income and expenses of the Trust within three months of the close of the year of account. The trustees shall appoint one or more chartered accountants to audit the accounts of the trust. The accounts of the trust shall be audited every year. The trustees shall pay the annual remuneration for the auditor(s). Every appointment of the auditor shall be for one year at a time but retiring auditor shall be eligible for reappointment also.

15. No trustees shall be liable for any loss not attributable to his/her own dishonest act or of commission by him/her of an act amounting to a breach of trust and in particular he/she shall not be made liable for failure to take any proceedings against any co-trustees for any breach or alleged breach of trust committed by such co-trustees.

16. Each of the Trustees covenants with the trust that he/she will on vacating office do and execute all such acts, documents, mat-

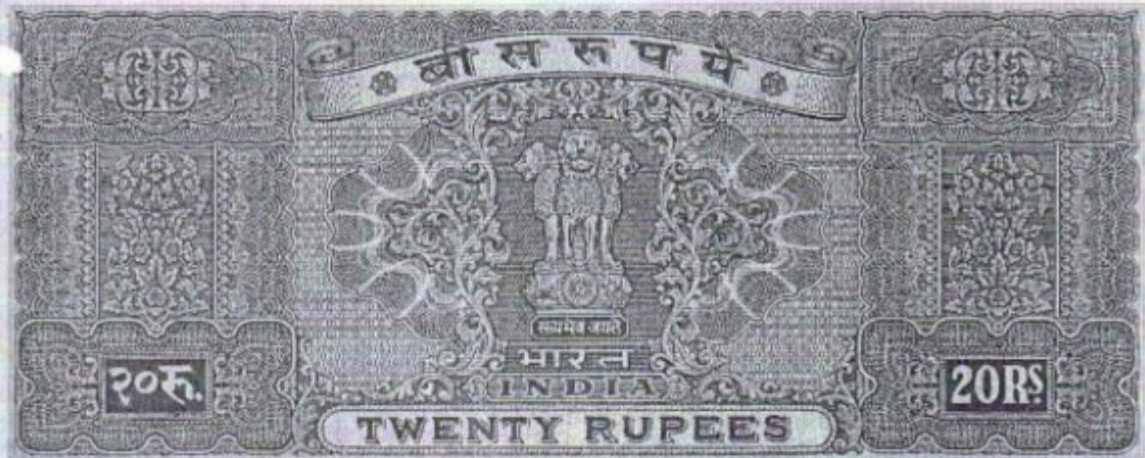
